EXHIBITOR APPLICATION INSTRUCTIONS / TERMS & CONDITIONS

Please make a copy of these instructions and Terms & Conditions for your records.

The West Marin OYSTERFEST takes place in downtown Point Reyes along one block of 4th Street, between A Street and B Street, with exhibitor display spaces down the center of the street, back-to-back facing the sidewalks.

Festival Weather: Point Reyes is usually cool and windy in the afternoon, and there is little shade on the street. Some form of shade protection in your set-up is recommended and ALL BOOTHS MUST BE WEIGHTED against our cooling "afternoon breeze."

Power: No Power is available for exhibitors, and generators are prohibited.

Selection: Preference is given to Arts and Crafts made by the Exhibitor, and local Specialty Foods. Considerations will be overall balance and presentation, so that no one medium will dominate. All applications are juried by category on a first come, first served basis. You will receive email confirmation upon receipt of your Application, **please check with us if you haven't received confirmation of receipt.**

An email notice will be sent within a month of submitting your application as to your application status.

Photos: Applicants are required to submit 3 photos or photocopies of your work, or a link to your web site, and one photo of your booth display with this signed application and your payment. If you are not selected your payment will be returned after jurying

Fees/Payment: If paying by Credit Card, a 3.5% convenience fee will be added to the total charged. If paying by check, please mail to us with your application. Participation fees are based on space size and the date the application is received. **Applications received after July 15th must include payment at the higher rate – please submit your application early.** Please make the checks payable to: **Pacific Expositions.** There is a \$25.00 charge for any returned checks.

Resale Number: The State Board of Equalization requires us to report all vendors and their Resale #. Please supply on the application, or if exempt, supply your Driver's License # and reason for exemption.

Space Assignment & Final Instructions: Exhibitors accepted by August 15th, 2026 will receive their space assignment and final instructions approximately 4 weeks prior to the festival. Prior year space is considered only for applications received by July 15th. **This is not a guarantee.** Applications received after July 15th, 2026 will be assigned on a first come basis.

Withdrawal: Exhibitors may withdraw up until July 15th to receive a 50% refund. **After July 31st, participation fees are not refundable.** All requests for withdrawal must be received in writing, email is acceptable.

Cancellation: If weather, acts of God, or other circumstances beyond the control of Pacific Expositions cause the event to be cancelled, participation fees will not be returned.

Special Notes:

When should you apply? **Apply early** as this event will fill up quickly! Exhibitors are responsible for providing their own insurance for the event. Checks from accepted artists will be deposited upon acceptance.

EXHIBITOR RELEASE & HOLD HARMLESS AGREEMENT

This agreement is entered into by and between Pacific Expositions (Producer), and (Presenting Organization) and the Exhibitor named below (Exhibitor).

Producer is in the business of providing space at the West Marin OYSTERFEST event for the display and sale of arts, crafts and specialty food products. Producer and Presenting Organization do not participate in the construction, assembly, or placement of the individual Exhibitor's presentation. The Producer and the Presenting Organization, provides space only at the event.

The Exhibitor hereby indemnifies and holds the Producer and the Presenting Organization, its agents, employees and servants harmless from any and all claims, including costs and attorney's fees resulting there from, arising out of said Exhibitor's participation in this event. For the purpose of this agreement, the term "participation" shall include, but not be limited to, the delivery of equipment, merchandise, structures and product to their designated location, the set up and display of any such structure arts or crafts and specialty foods, and the dismantling and removal of all such items from the area.

I understand that neither Producer or Presenting Organization are responsible for lost, stolen or damaged equipment or merchandise or accident/injury to me or my staff and do hold harmless any of the above individuals or businesses for any and all liability. I have read the Terms & Conditions and will abide by them.

This agreement shall be effective immediately upon execution and shall continue in effect throughout the event period.
